This Event DJ Services Addendum ("Addendum") supplements and is governed by the DJ Xhlo Master Services Agreement ("Agreement"). All terms of the Agreement remain in effect unless modified here.

1. SERVICE DESCRIPTION

DJ Xhlo will provide professional DJ services for private, corporate, nightlife, wedding, and special events as booked by the Client. Services may include:

- Basic crowd engagement
- Standard DJ equipment (unless otherwise stated)

2. BOOKING & DEPOSIT

Services are provided for the number of hours booked. Overtime is not guaranteed and is subject to DJ Xhlo's availability.

DJ Xhlo will not play content deemed unsafe, inappropriate, or in violation of venue rules.

6. EVENT INTERRUPTIONS

DJ Xhlo is not liable for performance interruptions caused by:

-  **Venue limitations**
-  **Power failures**
-  **Weather**
-  **Client or guest behavior**
-  **Third-party vendors**

No refunds will be issued for interruptions beyond DJ Xhlo's control.
