# 1. SERVICE DESCRIPTION

DJ Xhlo will provide professional DJ services specifically designed for senior living communities, assisted living facilities, community centers, and similar group environments. Services may include:

And pacing appropriate for seniors

## 2. BOOKING & PAYMENT TERMS

### Minimum Requirements

**Deposits are non-refundable.**

### Payment Schedule

Remaining balances must be paid on or before the event date, unless otherwise agreed in writing.

### 3. VOLUME, CONTENT & PACING

## 4. SONG REQUESTS

Song requests are welcomed when appropriate. Requests may be declined if they are:



**Inappropriate for the audience**



**Disruptive to the overall flow**



**Outside the agreed event style**

# 5. FACILITY RESPONSIBILITIES

**Client or Facility agrees to provide:**

- A safe and accessible setup area
- Power access
- Clear communication regarding volume expectations, time restrictions, and resident needs
- A designated contact person during the event

 DJ Xhlo is not responsible for delays or limitations caused by facility access restrictions or operational policies.

## 6. EVENT DURATION & EXTENSIONS

### Standard Services

Services are provided for the booked duration.

Additional time is subject to DJ Xhlo's availability.

### Extensions

Approved extensions are billed at the agreed hourly rate and must be approved before the original end time.

# 7. CANCELLATIONS & RESCHEDULING

## **Cancellations**

Cancellations result in forfeiture of any deposit paid.

## **Rescheduling**

Rescheduling requests are subject to availability.

## **DJ Xhlo's Rights**

DJ Xhlo reserves the right to cancel services due to unsafe conditions, harassment, or non-payment without refund.

## 8. MEDIA & PRIVACY

**DJ Xhlo will not record residents or attendees without prior facility approval.**

Promotional media will only be captured with written consent from the facility.

- **Attendance numbers**
- **Resident participation levels**
- **Specific reactions or outcomes**
