## Full payment is required

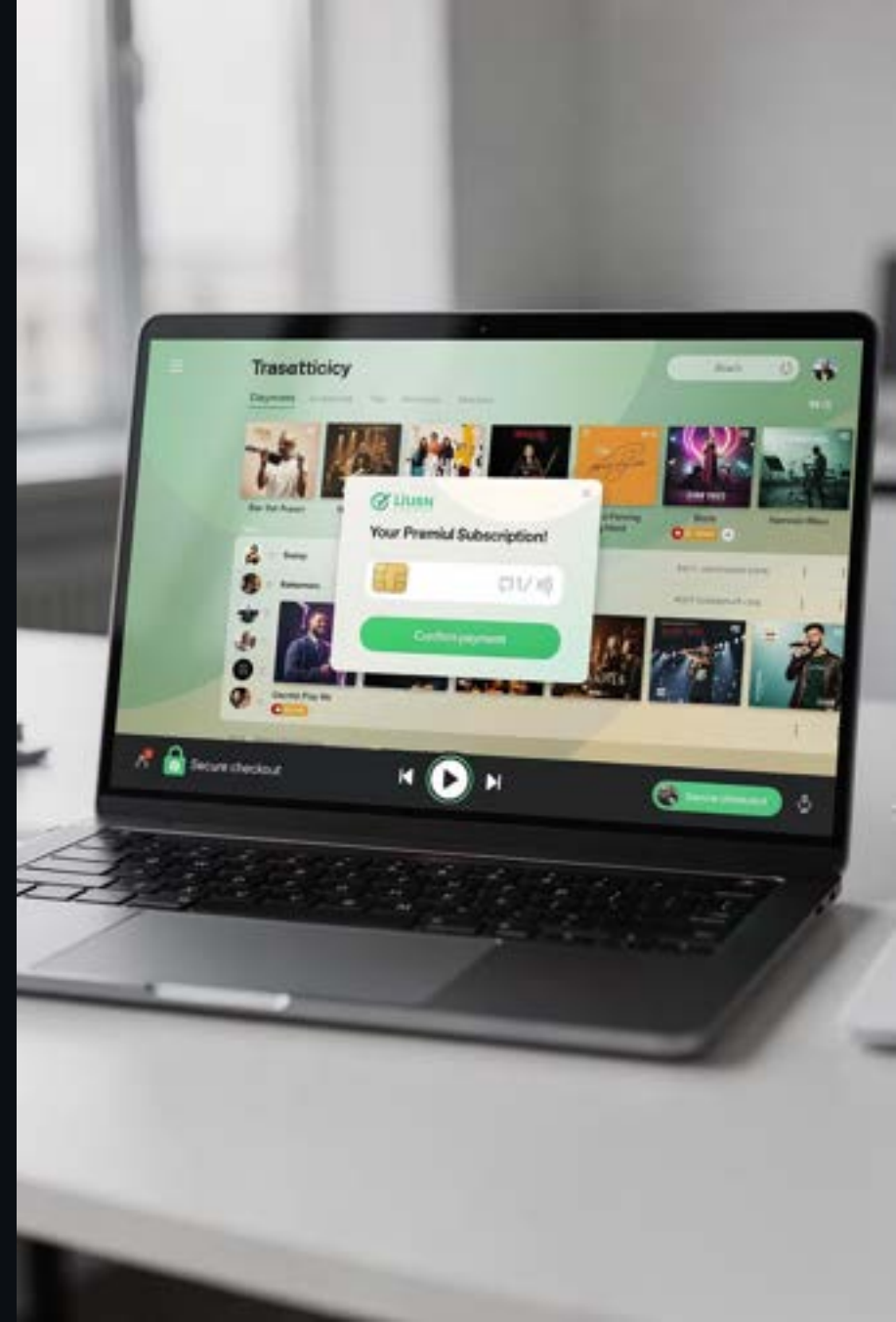
